Provisions to be used at the discretion of the Bishop of Providence
(These gifts grant the Bishop the flexibility to apply gifts where needed most)

(All of the rest, residue and remainder of my estate I give, devise, and bequeath)* to the CATHOLIC FOUNDATION OF RHODE ISLAND, a non-profit corporation organized and existing under the laws of the State of Rhode Island, IN TRUST to create a separate fund to be known as the “_____ Fund” of the Catholic Foundation.

The principal of this Trust Fund shall be retained by the Catholic Foundation of Rhode Island as part of its endowment fund and shall distribute its income, and any accrual thereof, at the discretion of the Bishop of Providence, Rhode Island and the Board of Governors of the Catholic Foundation of Rhode Island.

Should the Catholic Foundation of Rhode Island cease to exist, I direct that the principal and any accumulated interest of the “_____ Fund” of the Catholic Foundation be turned over to the operation and control of the Roman Catholic Bishop of Providence who shall maintain said Trust Fund in accordance with my wishes and instructions herein.
